The purpose of this modification is to exercise the second option year of the subject contract in accordance with Federal Acquisition Regulation Clause 52.217-9 - Option to Extend the Term of the Contract. As a result, the ceiling of this contract is increased by \$12,293.50 from \$35,680.50 to \$47,974.00. Accordingly, the following changes are hereby made:

1. The first sentence in paragraph (a) of Section B.3 - Consideration and Obligation is hereby deleted in its entirety and substituted in lieu thereof the following:

"(a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$47,974.00."

2. Section F.2 - Duration of Contract Period, is hereby deleted in its entirety and substituted in lieu thereof the following:

"The ordering period for this contract shall commence on 2/15/94 and will expire on 2/14/98. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216-8 - Ordering.) The term of this contract may be extended at the option of the Government for an additional one (1) one-year period."
