This refers to the announced preoperational physical security inspection conducted by Messrs. J. R. Kniceley, T. J. Madedo and B. Drouin of this office on July 8-12, 1985, of activities at Perry Nuclear Power Plant, Unit 1 authorized by NRC Construction Permit No. CPPR-148 and to the discussion of our findings with Mr. J. J. Waldron and other members of your staff at the conclusion of the inspection.


