The purpose of this modification is to:

1. revise subsection F.3 DURATION OF CONTRACT PERIOD by revising the expiration date to November 15, 1996;
2. revise paragraph c of clause I.4 52.217-9 - OPTION TO EXTEND THE TERM OF THE CONTRACT (MAR 1989) by revising the total maximum duration of the contract by an additional 4 months and one week.

Accordingly, the contract is hereby modified as follows:

1. Under subsection F.3 DURATION OF CONTRACT PERIOD, delete the paragraph entirely and the following paragraph is substituted in lieu thereof:

Performance under this contract shall commence on July 13, 1993, and will expire at 12 noon on November 15, 1996.
2. Under clause I.4, 52.217-9 - OPTION TO EXTEND THE TERM OF THE CONTRACT (MAR 1989) paragraph c is deleted in its entirety and the following paragraph is substituted in lieu thereof:

(c) The total duration of this contract, including the exercise of any options under this clause, shall not exceed 3 years and 4 months and one week.
