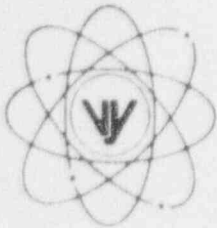

SUMMARY OF OPERATING EXPERIENCES

Highlights

Vermont Yankee operated at 00.0% of rated thermal power for the month. Gross electrical generation was 0 MWHe or 0% design electrical capacity.

Operating Summary

The following is a chronological description of plant operations including other pertinent items of interest for the month:

At the beginning of the reporting period the plant was operating at 00.0% of rated thermal power.

961030 At 2210 hours, the reactor was critical and a return to full power was initiated. (See Unit Shutdowns and Power Reductions)

At the end of the reporting period the plant was operating at 2.3% of rated thermal power.
