Manoly of this office on July 8 - 12, 1985, at Millstone Nuclear Power Station, Unit #3, Waterford, Connecticut, of activities authorized by NRC License No. CPPR-113 and to the discussions of our findings held by K. Manoly with K. Gray of your staff at the conclusion of the inspection.
