Pursuant to the Atomic Energy Act of 1954, as amended, the Energy Reorganization Act of 1974 (Public Law 93-438), and Title 10, Code of Federal Regulations, Chapter I, Parts 30, 31, 32, 33, 34, 35, 36, 37, 39, 40, 70 and 71, and in reliance on statements and representations heretofore made by the licensee, a license is hereby issued authorizing the licensee to receive, acquire, possess, and transfer byproduct, source, and special nuclear material designated below; to use such material for the purpose(s) and at the place(s) designated below; to deliver or transfer such material to persons authorized to receive it in accordance with the regulations of the applicable Part(s). This license shall be deemed to contain the conditions specified in Section 183 of the Atomic Energy Act of 1954, as amended, and is subject to all applicable rules, regulations, and orders of the Nuclear Regulatory Commission now or hereafter in effect and to any conditions specified below.

13. The licensee shall not vacate or release a storage location for unrestricted use whose address is identified in Condition 10, without prior U.S. Nuclear Regulatory Commission approval. Records as described in 10 CFR 30.36(j) shall be submitted to support the request for unrestricted use.
14. The licensee shall ensure that each source holder or tool containing radioactive material bears a durable and clearly visible label bearing the radiation symbol and the words "Caution, Radioactive Material." The label must be on the smallest component that contains the licensed material which is transported as a separate piece of equipment.
15. Sealed sources containing licensed material shall not be opened or sources removed from source holders by the licensee.
16. The licensee will continue to take all actions within its ability to dispose of the licensed material and notify the U.S. Nuclear Regulatory Commission within 30 days if disposal is achieved.
