


The purpose of this modification is to (1) extend the period of performance (2) add rate of payment for CY 1997 and (3) provide incremental funding in the amount of \$53,000 for CY 1997. As a result of this action, the total amount obligated is \$530,149. Accordingly, the following changes are hereby made:

1. Article III - PERIOD OF PERFORMANCE, Paragraph A. is revised to read as follows:

"A. The period of performance hereunder shall commence on January 1, 1983 and shall continue through December 31, 1997, unless sooner terminated or extended, as herein provided.

2. Article V - CONSIDERATION AND PAYMENT, Paragraph A., Consideration, Paragraph 1., is revised to read as follows:

"1. The Commission will provide funds to the State in the amount of \$530,149 during the fourteen (14) year period of performance. The rate of payment to the State for calendar year 1997 is as follows:

CY-1997 - \$16,000 per site (3), per year for EM Programs
CY-1997 - \$ 2,500 per site (2), per year for TLD Programs"

3. Article V - CONSIDERATION AND PAYMENT, Paragraph A., Consideration, Paragraph 3., is revised to read as follows:

"3. The amount presently obligated by the Commission with respect to this cooperative agreement for the CY-1997 effort is \$53,000. The total amount obligated since inception of this agreement is increased by \$53,000 from \$477,149 to \$530,149."

All other terms and conditions under this Cooperative Agreement remain unchanged.
