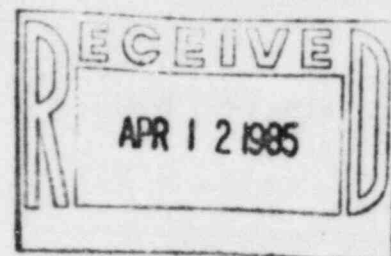

Gentlemen:

In reply to your letter of violation and proposed penalty I would like to state that the incidents for which I was cited showed that I was not as thorough as I should have been and I feel that the proposed penalty was justified.

There is no excuse as I indicated to you in our meeting in Arlington, and we will continue to do everything we can to see to it that these problems or other ones do not arise again. Also we are going to do all that we can do to erase whatever effect it may have had on your attitude towards our company.

The following has been done to insure that we are in compliance:

#1. Sources are no longer being stored at facility at 5500 E. Independence, Tulsa, Oklahoma, until we can get that storage facility on our license.

#2. The facility at 5500 E. Independence has been appropriately reconstructed to comply with 10 CFR 20.105 (b)(1.).

#3 All employees have been strictly reminded of the requirements of 10 CFR 20.201 (b). and are randomly spot checked for compliance.

#4 Shortly after our inspection our facility at 5500 E. Independence was equipped with lights and warning devices to bring it into compliance with 10 CFR 34.29 (b).

#5 All radiographers have now availability to dosimeter chargers if they do not come in to the office every day whether in is in a vehicle or at a permanent job site. This to comply with 10 CFR 34.33(a).

#6 All new employees regardless of previous experience are given a field competency exam by the Radiation Safety Officer before being given a job assignment and records are maintained to document this.
