Dear Mr. deCamp:

I am responding to your letter of December 17, 1996, to Chairman Jackson regarding the petitions you filed on May 11, and June 14, 1996, pursuant to Title 10 of the Code of Federal Regulations, Section 2.206 (10 CFR 2.206). The Director's Decision (DD-96-22) was sent to you under a cover letter dated December 11, 1996, and responds to your concerns regarding fuel offloading at Oyster Creek Nuclear Generating Station.

Regarding your statement that you had not received a response to your Petition, we note that the project manager for Oyster Creek Nuclear Generating Station apprised you of the status of the Petition in a telephone conversation with you on July 16, 1996, and in a message left on your voice message system on October 8, 1996. As noted above, the Director's Decision that fully responds to your Petition was issued and mailed to you on December 11, 1996. Another copy of this Director's Decision is enclosed for your use.
