SUBJECT: REQUEST FOR REVIEW AND COMMENT ON DRAFT INTEGRATED TEAM  
INSPECTION SCHEDULE

I am forwarding for your information and review the preliminary list of planned NRC team inspections for the third and fourth quarters of FY 93 along with the inspections that occurred within the past six months. We have reflected in this schedule headquarters inspection activities which might impact on the scheduling of team inspections. The draft schedule is based on our review of the Master Inspection Planning System (MIPS). A printout from MIPS is also enclosed for your information.

The regional offices should discuss the scheduled team inspection activities as appropriate with affected utilities to determine whether the inspections impose unreasonable impacts on the licensees. If changes in the schedule are needed because of such impacts, these should be discussed with NRR Reactor Projects management and provided to this office for incorporation into the schedule. The regions should incorporate these changes into MIPS. The schedule is for Official Use Only and should be handled accordingly.

I would like to commend the regions for the progress made in reflecting site activities in a timely and accurate manner in the MIPS. As documented in previous memoranda, we intend on replacing the integrated schedule maintained by the Division of Reactor Inspection and Licensee Performance (DRIL) with the MIPS schedule. Therefore, it is important that MIPS be maintained as an accurate snapshot of planned inspection activities at any point in time. The transition to MIPS will occur in June 1993. Subsequently, the MIPS data, rather than the integrated schedule, will be independently reviewed by the management of DRIL and the NRR Divisions of Projects on a quarterly basis. As is currently the case, the regions will be provided comments from the NRR review by their respective Division of Projects and asked to evaluate areas seen as having potentially high regulatory impact.
