Subject: CONFIRMATORY ACTION LETTER (CAL) NO. 1-96-005 DATED APRIL 9, 1996

Dear Mr. Wingert:

This letter refers to your letter dated November 5, 1996. Thank you for providing us with the status of your demobilization efforts, as well as your draft termination plan for the closing of the National Instrumentation Center (NIC). According to this draft plan, the NIC will be closed by June 1997. Please note that 10 CFR 30.36(h) (enclosed) states that licensees shall complete decommissioning of the site as soon as practicable but no later than 24 months following the initiation of decommissioning. Therefore, before you submit your final termination plan, be sure to check its compliance with this 24 month time requirement.

We understand that Mr. Philip McIntire will be your successor as the Chairman of the Radiation Control Committee (RCC), and will submit the required monthly status reports beginning on November 30, 1996. A change in the Chairman of the RCC requires an amendment to your license. Please submit a letter to this office requesting an amendment to your license and include Mr. McIntire's qualifications for our review.
