In accordance with the task order procedures of the subject contract, this letter definitizes Task Order No. 10(C). This effort shall be performed in accordance with the enclosed Statement of Work and the Contractor's technical proposal dated November 12, 1996, which is hereby incorporated by reference and made a part of this task order. The effective date of this task order shall be January 27, 1997.

Task Order No. 10(C) shall be in effect from January 27, 1997 through September 26, 1997 with a cost ceiling of \$76,732. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this task order. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk.


