I am responding to your July 23, 1996, letter, regarding Invoice No. AM2343-96 for License No. 52-19670-01. Your letter states that you were confused with the different expiration dates. Here is an explanation I hope will be helpful to you. Invoice AM2343-96 is for payment of the annual fee for fiscal year 1996. The period for which the invoice was billed is October 1, 1995, through September 30, 1996. It is not a renewal fee. The notification you received extending the license by five years does not relate to this invoice. The expiration date of your license is October 31, 2001. The anniversary month on the invoice is March. This is the month the license was originally issued; under current regulations you will be invoiced each year in March for the annual fee.
