SUBJECT: REQUEST FOR TRANSCRIPT ERRATA


Dear Mr. Briggs:

This letter is in response to a telephone conversation between Mr. Mark Satorius and you on January 27, 1995. During this conversation, you requested a copy of the transcript errata to a February 16, 1994 Office of Investigations (OI) transcript of an interview with your client, Mr. Vincent J. Polizzi.
