

It has been necessary in recent months to assign personnel to space in Wings A, B, and C of the ground floor of the Headquarters Building, which also is designated as office space for the Emergency Relocation Center, Headquarters (ERC-H).

Therefore, the desk locations specified in the attachment to my memorandum of April 24, 1961, subject: ERC-H Location Directory, may not be accurate at this time. However, office assignments for the various divisions and offices remain unchanged except for the addition of the Divisions of Compliance and Contracts and the deletion of the Division of Special Projects.
