Ladies and Gentlemen:

On behalf of Community Hospital of Anderson and Madison County, Incorporated ("CHA"), we are writing to inform you that on August 8, 1996, CHA and Community Hospitals of Indiana, Inc. ("CHI") entered into an Affiliation Agreement, pursuant to which the parties have agreed to affiliate and consolidate certain efforts and functions to enable the parties to offer additional and more extensive health care services and to benefit from economies of operations and strengthened long term financial viability ("Affiliation").

Pursuant to the Affiliation, CHI is the sole member of CHA, but CHA will continue as a separate tax-exempt nonprofit corporation and maintain a separate medical staff organization. No merger between the parties has taken place, and no additional corporation, partnership or other entity has been created or formed to facilitate the Affiliation. Neither the name of CHA nor CHI will change as a result of the Affiliation.
