
I am responding to your July 25, 1996, letter regarding Invoice No. AM1841-96 for License No. 11-29082-01 and Invoice No. AM0530-96 for Quality Assurance Program Approval No. 0792 (QA-0792).

Your letter states that NDE Services did not possess radioactive material or perform work since September 15, 1995, and sold its radioactive material and went out of business September 15, 1995. Attempts to transfer the license and to sell the business were not successful and License No. 11-29082-01 was terminated June 6, 1996, based on your NRC Form 314 dated May 17, 1996. QA-0792 was terminated August 15, 1996, based on your July 25, 1996, letter.

You request a waiver of Invoice Nos. AM1841-96 and AM0530-96. Footnote 1 of 10 CFR 171.16 provides that the annual fee is waived when a license is terminated prior to October 1 of each fiscal year. The 1996 annual fee is waived for licensees and holders of certificates, registrations, and approvals who either filed for termination of their licenses or approvals or filed for possession only/storage only licenses prior to October 1, 1995, and permanently ceased licensed activities by September 30, 1995.

Based on the information provided, the NRC: 1) grants an extension of time to file for termination to May 17, 1996, for purposes of avoiding the FY 1996 annual fee for License No. 11-29081-01; 2) acknowledges you ceased possession of any licensed material September 15, 1995; and 3) grants an extension of time to file for termination to July 25, 1996, for purposes of avoiding the FY 1996 annual fee for QA-0792. Invoice Nos. AM1841-96 and AM0530-96 are cancelled.
