The purpose of this modification is to: (1) extend the period of performance through April 30, 1997, at no additional cost or obligation to the Government, in accordance with the contractor's letter request dated January 31, 1997, and (2) revise the date the contractor will brief the NRC's Advisory Committee on Reactor Safeguards (ACRS). Accordingly, the contract is hereby modified as follows:

1. Under Section C.1, Statement of Work, paragraph 3 under Task 2/Phase II is revised as follows:

"3. Following the submission of a copy of the pre-published final report, NAS shall provide a briefing to NRC staff and ACRS to discuss the results of the Task 2/Phase II effort (March 6, 1997).

The meeting/workshop to be provided shall cover all issues defined in the Phase II report."

2. Section F.5, Duration of Contract Period, is deleted in its entirety and the following is substituted in lieu thereof:

"This contract shall commence on October 1, 1994 and will expire on April 30, 1997."

All other terms and conditions, including the ceiling amount of \$759,411.00, remain unchanged.

A summary of obligations, from the date of award through the date of this action, are as follows:
