Dear Mr. Ranta:

I am responding to your undated letter received August 26, 1996, and your telephone conversations concerning the annual fee for FY 1996 for Materials License 48-26639-01, Invoice AM4421-96. You believe the invoice is not applicable given these circumstances: 1) Roof Technologies, Inc. has never developed into a business; 2) there were never any employees, no income received or taxes due; 3) papers have been sent to dissolve the corporation; 4) fees should not be assessed due to non-existent status; and 5) you request removal of the license. We have forwarded a copy of your letter to our Region III Office for termination of Materials License 48-26639-01.

For the reasons stated above, we are terminating collection action on this account in accordance with 10 CFR Part 15 § 15.55. Enclosed is NRC Form 531 "Request for Taxpayer Identification Number", for you to complete and return. Written-off debts are reportable as income to the IRS.
