To add:

17. Byproduct material may also be used at 2240 Prospect Avenue, Cleveland 15, Ohio.

Conditions 12 and 16. C. are amended to read:

12. Byproduct material shall be used by, or under the supervision of, C. T. Schmidt, W. W. Managan, or J. Nixon.

16. C. If the test reveals the presence of 0.005 microcurie or more of removable contamination, the licensee shall immediately withdraw the sealed source from use and shall cause it to be decontaminated and repaired or to be disposed of in accordance with Commission regulations. A report shall be filed within 5 days of the test with the Director, Division of Licensing and Regulation, U. S. Atomic Energy Commission, Washington 25, D. C., describing the equipment involved, the test results and the corrective action taken. A copy of such report shall also be sent to the Director, Region III, Division of Compliance, USAEC, 9800 South Cass Avenue, Argonne, Illinois.
