This refers to the special safety inspection conducted by Laurence F. Friedman, Ph.D., C.H.P. and John E. Glenn, Ph.D. of this office on August 12, 1985, of activities authorized by NRC License Number 29-13848-01, and to the discussions of our findings held by Drs. Friedman and Glenn with yourself at the conclusion of the inspection.

The area examined during this inspection was limited to a review of ongoing de-commissioning activities at your facility. Our inspectors took three of your soil samples for analysis in the Regional Office Laboratory in King of Prussia, Pennsylvania. The basic purpose of these independent measurements was to verify your capability to analyze soil at your facility. The results of our analyses are in agreement with your results. Within this area, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, measurements made by the inspector, and observations by the inspector.

Within the scope of this inspection, no violations were observed.

In accordance with Section 2.790 of the NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations, a copy of this letter will be placed in the Public Document Room.
