Dear Ms. Cossey:

I am responding to your September 10, 1996, letter returning Invoice AM6141-96 for Materials License 13-24760-02. We are considering your case for an extension of time to avoid the FY 1996 annual fee based on the following:
1) you no longer possess a radiotherapy unit; 2) in September 1995, you replaced the cobalt machine with a linear accelerator; and 3) you believe no annual fee is due.

Footnote 1 of 10 CFR 171.16 provides that the annual fee is waived when a license is terminated prior to October 1 of each fiscal year. The 1996 annual fee is waived for those licensees and holders of certificates, registrations, and approvals who either filed for termination of their licenses or approvals or filed for possession only/storage only licenses prior to October 1, 1995, and permanently ceased licensed activities by September 30, 1995. An amendment request filed after October 1 of each fiscal year to cancel a license does not cancel the annual fee invoice. Your October 16, 1995, termination request was not timely filed for purposes of avoiding the FY 1996 annual fee.

Based on the information you have provided, the NRC: 1) grants an extension of time to October 16, 1995, for purposes of avoiding the FY 1996 annual fee; 2) acknowledges you permanently ceased licensed operations prior to September 30, 1995; and 3) acknowledges that License 13-24760-02 was terminated February 26, 1996, based on your October 16, 1995, request. Invoice No. AM6141-96 has been cancelled.
