Dear Ms. Holt:

In reference to our recent telephone conversation regarding our request of March 25, 1985 to amend Byproduct License No. 34-00811-03, issued to Republic Steel Corporation, please be advised as follows:

1. Regarding the request for the name change of the legal entity from Republic Steel Corporation to LTV Steel Company, Inc. because of the merger of Jones & Laughlin Steel Corporation and Republic Steel Corporation --

I have been advised by our Law Department that Jones & Laughlin Steel Corporation officially merged into Republic Steel Corporation and the surviving Republic Steel Corporation subsequently changed its name to LTV Steel Company, Inc.

Therefore, our request for amendment is simply a request for a name change of the surviving company, Republic Steel Corporation, to LTV Steel Company, Inc. as the legal entity.

Please find enclosed the State of New Jersey's certificate of merger as verification. Based on this consideration, it is felt that further separate correspondence from a former Republic Steel Corporation official is not necessary as was previously proposed.

2. It is our intent to follow the stated conditions of License No. 34-00811-03 as much as possible within the parameters of the new reorganized departmental structures.

Applicable radiation safety procedures will be followed at all times.

It is our goal to completely revise our radiation protection program within one year in order to reflect our new organizational responsibilities and applications of licensed materials.



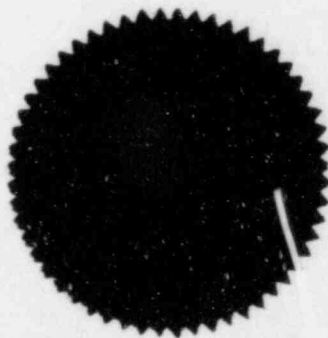
