The Region I Field Office, NRC Office of Investigations (OI), initiated an investigation (Case No. 1-2020-002) on October 8, 2019, to determine whether an Indian Point Energy Center supervisor falsified site access examinations for contract employees. Based upon documentary and testimonial evidence developed during the OI investigation, the NRC did not substantiate that the supervisor falsified site access examinations for contract employees. No violations of NRC requirements were identified.
