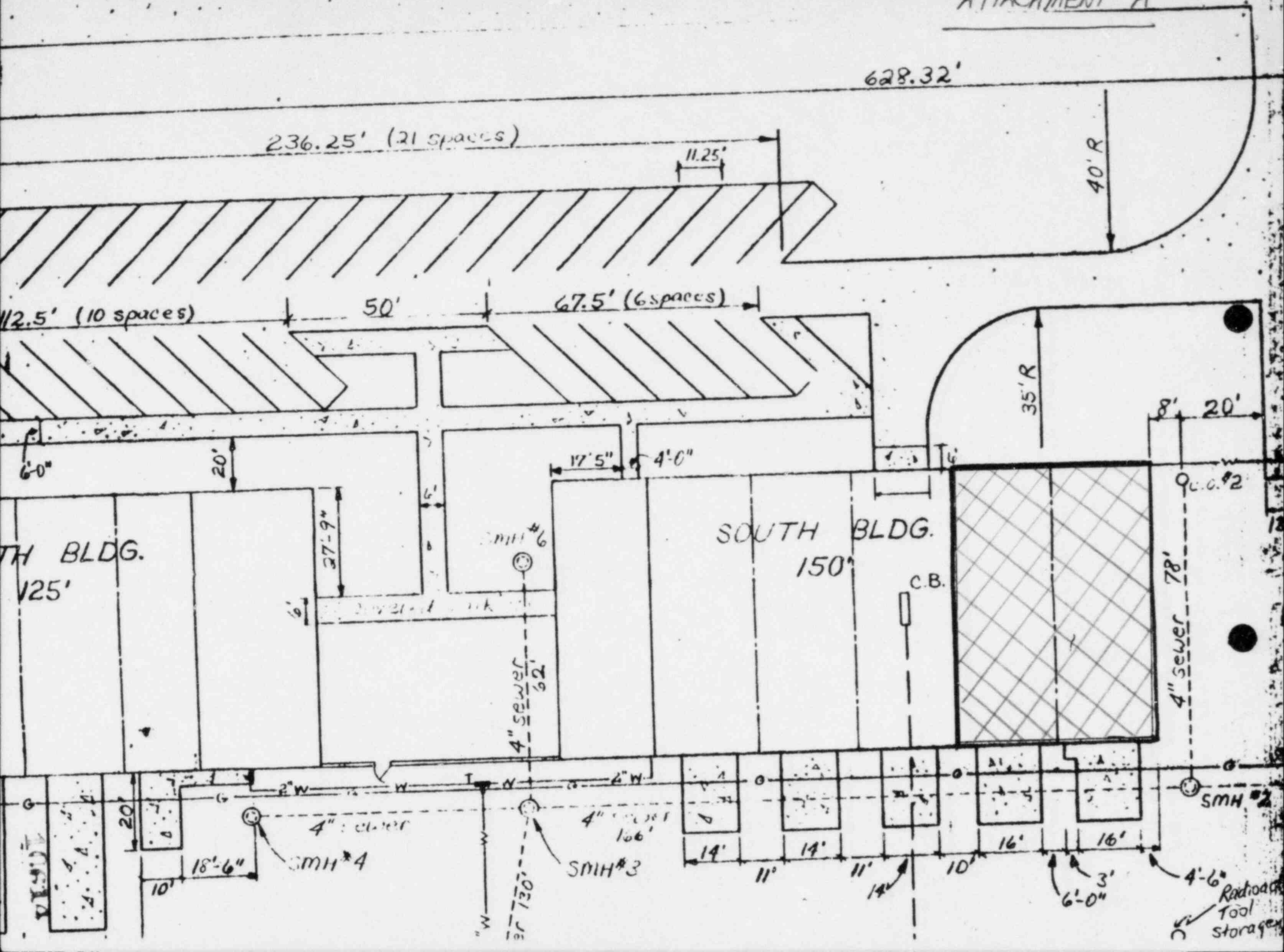

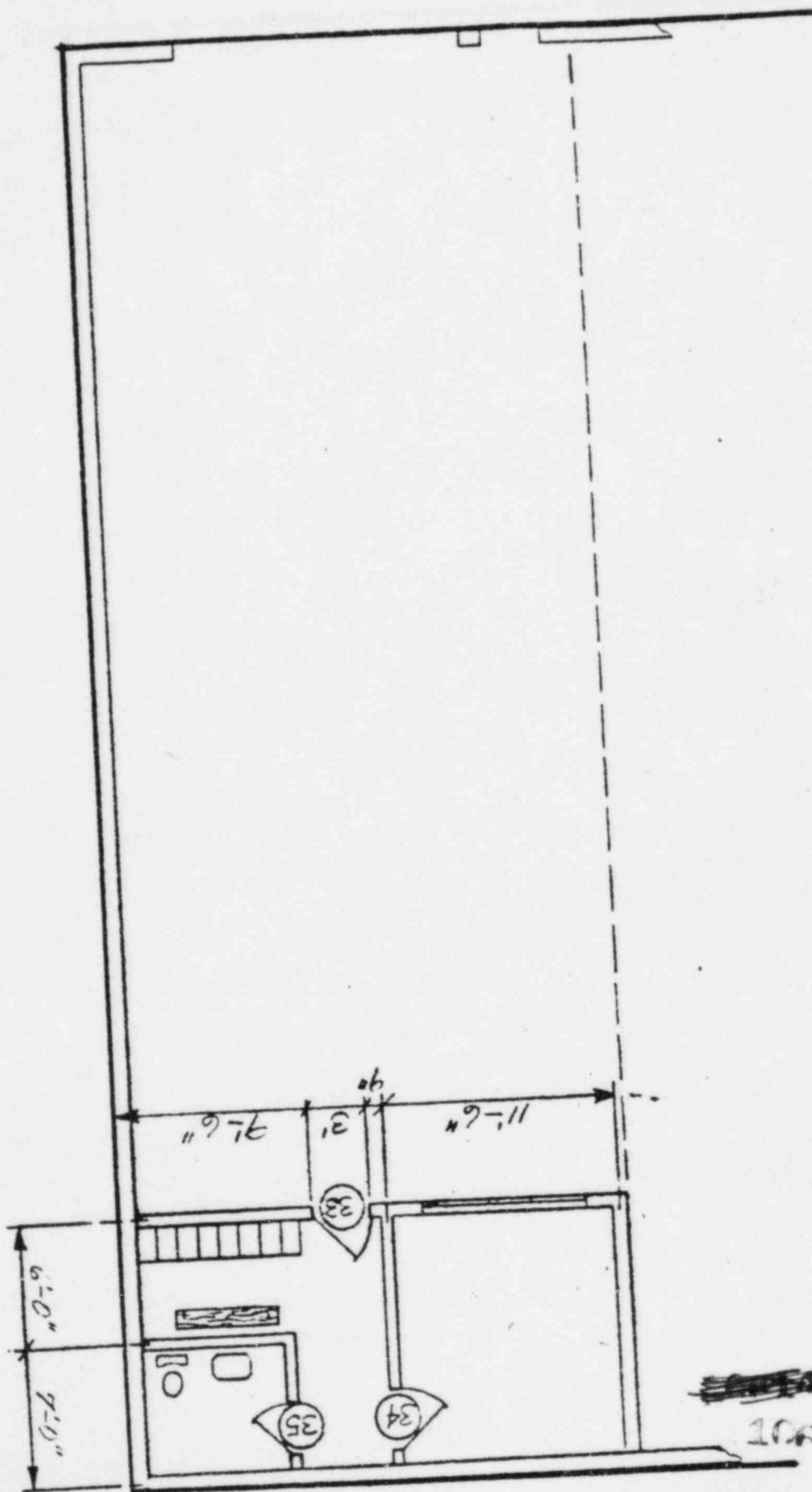
Item 13. The two trucks currently using the Nowata, Oklahoma location on Highway #60 will be moved to a new location on Highway #169, Nowata, Oklahoma, 1.3 miles north of the intersection with Highway #60.

The trucks and associated equipment will be stored in the cross-hatched area of the building shown in Attachment A. A more detailed drawing of the storage area is shown in Attachment B. The area will be used jointly with Selective Service, Inc., NRC Materials License No. 35-19705-01. The building is steel frame with sheet metal siding and roof and concrete floors. There are no windows in the storage area. The area used by Well Logging will be accessible by two locked steel overhead doors and one locked steel walk-in door without a window. In the near future the entire complex will be surrounded by a chain link fence.
