Greetings,

Whereas, a copy of "COMPREHENSIVE RADIOLOGICAL WASTE STORAGE AND DISPOSAL PLAN" for the Sequoyah Fuels Corporation of the Sequoyah Facility of Kerr-McGee near Gore, Oklahoma, License SUB -1010 Docket 40-8027, dated May 25, 1985 has just been made available to us, this letter serves as our official response.

Native Americans for a Clean Environment does believe that this plan is an actual threat to the safety and well being of the people of Eastern Ok. and therefore we demand that a public hearing be held before any further action is taken by the NRC on this proposed action.

To allow a disposal site to built on this property would be not only a health hazard to the present population, but would be a first step in establishing a nuclear waste dump for the Central Interstate Pact, of which Ok. is a member. We cannot allow this to happen, therefore we will oppose the licensing amendment that would permit such an action to ever occur.

The safety of the present plant is under such suspicion that no other amendments should be considered until the questions at present are answered. We (NACE) therefore, request that all SFC changes be put on hold until issues pending are dealt with.
