We received our license (06-15298-02) on June 24, 1985 and I am requesting that it be ammended if possible.

I believe that our initial application was not complete enough in regard to the Ni 63 detector for the gas chromatograph. The detector is in storage and we have no immediate plans for its installation or use.

I am therefore requesting that our license be ammended so as not to require a wipe (leak) test every six (6) months while the detector is in storage. Should the detector be used, then a wipe test would be performed prior to installation and every six months thereafter.
