SUBJECT: EXPIRED LICENSE, BRADY CONTRACTING COMPANY, INC., CAMP HILL, PENNSYLVANIA

On July 25, 1985 Region I received a letter, dated July 23, 1985, from Anita Brokans, Contract Administrator, for Brady Contracting Company, Inc. The licensee representative explained that they have received and possessed licensed material, but now possess no licensed material and wish to have the license terminated. The licensed material was sold to Primo Contracting, Inc., Exton, Pennsylvania, in October 1983. This was confirmed by contact with Mr. J. Colona, Authorized User of Primo Contracting, Inc., License No. 37-20650-01, who confirmed that they had received the Troxler gauge from the licensee approximately two years ago and that they are authorized to possess this material.

Based on a review of the information supplied by the licensee and a review of the type and form of material authorized by the license, a close out survey by the licensee is not required and this license may be retired.

Based on the above information, we have retired License No. 37-19447-01. Please remove it from your active shelves.
