Gentlemen:

The University of Connecticut Health Center requests an amendment to Byproduct Material License No. 06-13022-02 to correct an oversight. Condition 10B. of the license authorizes the Health Center to use licensed material listed in Subitems 6.F., 6.H., 6.J., and 6.L. at the Veterans Administration Medical Center, Newington, Connecticut. Subitem 10.I. which authorizes the possession and use of tritium was apparently omitted. The University of Connecticut Health Center requests that Condition 10B be amended to include Subitem 6.I. so that tritium may be possessed and used at the V.A. under our license.

The University of Connecticut Health Center is exempt from license fees under 10CFR170, Section 170.11 (a) (9).
