
An NRC inspection was conducted February 16 through March 29, 1997, at your Callaway Plant reactor facility. The enclosed report presents the scope and results of that inspection.

Should you have any questions concerning this inspection, we will be pleased to discuss them with you.

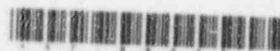
