SUBJECT: COMPLETION OF REQUIREMENTS OF ORDER MODIFYING LICENSE

On June 18, 1984, an Order Modifying License was issued to Philadelphia Electric Company (PECo) to submit a plan to appraise and improve the safety evaluation process, plant operating procedures, and procedure review program at Peach Bottom Units 2 and 3. On October 19, 1984, NRC approved PECO's plan which utilized an independent consultant team to conduct the appraisal and recommend improvements.

We have reviewed the appraisal results and your letters of February 25, 1985, April 3, 1985 and November 25, 1985 in response to the Order which detail your actions to implement the appraisal recommendations. No deficiencies were identified; accordingly, all terms of the Order have been satisfactorily completed.
