SUBJECT: FEE FOR LICENSE 25-10994-03

License 25-10994-03 was issued on April 16, 1985, to replace License 25-14896-01. The license was issued in accordance with application dated January 10, 1985 and letters dated February 20 and 26, 1985, requesting that License 25-14896-01 be amended to reflect Bozeman Deaconess Hospital as the licensee rather than Intercity Radiological Laboratories. An amendment fee of \$230 was paid on January 23, 1985, for the amendment request.

Since Bozeman Deaconess Hospital possesses other materials licenses, the Licensing staff elected to terminate License 25-14896-01 and issue new License 25-10994-03 in order to maintain the correct institution code for all licenses issued to the hospital. Since the new license was issued to maintain the correct institution code for the licensee, and since, except for very minor changes, all conditions of the license remained the same, the \$230 amendment fee collected on January 23, 1985 is the correct fee for License 25-10994-03.
