2. Article V, Consideration and Payment, Paragraphs A.1 and 3 are revised as follows:

A. Consideration

1. The Commission has provided funds to the State in the amount of \$88,450.00 for the three year period of performance, CY1983 through CY1985, in accordance with a through c below. Funds in the amount of \$33,400.00 are hereby provided to the State to cover performance for CY1986 in accordance with d below. The Commission will provide funds subject to the availability of appropriation to the State in the amount of \$71,400.00 during the remaining two year period of performance for CY1987 through CY1988 in accordance with e through f below. The rate of payment for d through f below will be as follows:
  - a. CY1983 - \$ 9,600.00 per site, per year/environmental media program  
CY1983 - \$ 1,300.00 per site, per year/TLD program  
CY1983 - \$ 4,800.00 per site, per year/modified environmental media program
  - b. CY1984 - \$10,600.00 per site, per year/environmental media program  
CY1984 - \$ 1,450.00 per site, per year/TLD program  
CY1984 - \$ 5,300.00 per site, per year/modified environmental media program
  - c. CY1985 - \$11,700.00 per site, per year/environmental media program  
CY1985 - \$ 1,600.00 per site, per year/TLD program  
CY1985 - \$ 5,850.00 per site, per year/modified environmental media program
  - d. CY1986 - \$12,000.00 per site, per year/environmental media program  
CY1986 - \$ 1,700.00 per site, per year/TLD program  
CY1986 - \$ 6,000.00 per site, per year/modified environmental media program
  - e. CY1987 - \$12,600.00 per site, per year/environmental media program  
CY1987 - \$ 1,800.00 per site, per year/TLD program  
CY1987 - \$ 6,300.00 per site, per year/modified environmental media program
  - f. CY1988 - \$13,000.00 per site, per year/environmental media program  
CY1988 - \$ 1,900.00 per site, per year/TLD program

2. The amount presently obligated by the Commission with respect to this cooperative agreement for CY1986 is \$33,400.00.

## ENVIRONMENTAL RADIOLOGICAL VERIFICATION MONITORING PROGRAM AROUND NUCLEAR POWER PLANTS

Radioiodine	Same as particulates.	One sample per month.	Analyze for I-131
WATERBORNE: Surface	One sample, split with licensee, from immediate area of discharge, (or at nearest downstream drinking water supply) and one sample at upstream control location.	Composite sample monthly. <sup>a</sup>	Gamma isotopic analysis monthly and tritium quarterly.
INGESTION: Milk	One sample, split with licensee, at the off-site dairy farm or individual milk animal at the location having highest X/Q.	Monthly.	Gamma isotopic and radioiodine analyses.
Fish or Invertebrates	One sample, split with licensee, of a commercially or recreationally important species in vicinity of discharge point.	Semiannually or in season.	Gamma isotopic of edible portions.

a. For I-131 analyses of drinking water supplies, samples shall be composited over a maximum period of two weeks.
