This refers to the routine safeguards inspection conducted by Mr. R. J. Bailey of this office on September 18-20, 1985 of activities at the Calvert Cliffs Nuclear Power Plants Units 1 and 2, Lusby, Maryland, authorized by NRC License Nos. DRP-53 and DRP-69 and to the discussions of our findings held by Mr. Bailey with Mr. L. P. Gibbs of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, no violations were observed.
