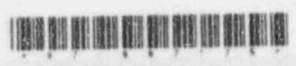

The purpose of this modification is to provide incremental funding which increases the obligated amount by \$26,501.00 from \$189,607.00 to \$216,108.00. Accordingly, the contract is modified as follows:

The first sentence of paragraph (b) in Section B.4 entitled "Consideration and Obligation--Delivery Orders (JUN 1988)" is deleted entirely and replaced with the following:

"(b) The amount presently obligated with respect to this contract is \$216,108.00."
