Dear Dr. Fernández:

This letter refers to our Order Modifying NRC Materials License 52-25114-01, dated October 21, 1996. Section IV.C.1 required you to report to the NRC, within 60 days of acceptance of your consultant by the NRC, the results of your consultant's review of misadministrations. In a letter dated March 7, 1997, your consultant requested a relaxation of the Order to extend the time to complete an updated report pursuant to 10 CFR 35.33 (a)(2) and provide NRC with a copy. According to our records, your review originally was due March 7, 1997, and your report was due on March 22, 1997.

Our understanding is that the basis for your request is to allow time to verify receipt of notification by patients who may have been the subject of misadministrations. This is an acceptable reason. In accordance with Section IV of the Order, we are relaxing for good cause, the original report due date of March 22, 1997 by extending your date for the report to April 1, 1997.


