This refers to the special safety inspection conducted by Laurence F. Friedman, Ph.D., C.H.P., of this office on January 10, 1986, of activities authorized by NRC License No. 08-03604-04 and to the discussions of our findings held by Dr. Friedman with yourself, Mr. Dunlop Ecker, President, and Ms. Barbara Ritz, Assistant Administrator for Ambulatory Services, at the conclusion of the inspection. This also refers to the telephone conversation between yourself and Dr. John Glenn of this office on February 4, 1986.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspector.

As discussed during the telephone conversation between yourself and Dr. Glenn the apparent violation identified during the inspection will be discussed at an Enforcement Conference to be held at our office in King of Prussia, Pennsylvania, at 1:00 p.m. Friday, February 21, 1986. We understand that you will attend this meeting with members of your staff. You should be prepared to discuss the causes of this apparent violation and your proposed corrective action. Enforcement action for this apparent violation will be considered by the NRC following the conference.

For your information, a copy of the NRC Enforcement Policy, described in Appendix C of 10 CFR Part 2, is enclosed.

In accordance with 10 CFR 2.790(a) a copy of this letter and the enclosure will be placed in the Public Document Room.






