The purpose of this modification is to revise Section G.1., entitled Contract Ceiling and Obligation. Accordingly, the following revisions are accomplished:

Section G.1., - Contract Ceiling and Obligation, is modified as follows:

1. First paragraph, first sentence is revised as follows:

"The contract ceiling for performance of work under this contract is increased from \$1,000,000 by \$160,000 to \$1,160,000."
