SUBJECT: RELOCATION OF REGION II OFFICE


Dear Dr. Vernetson:



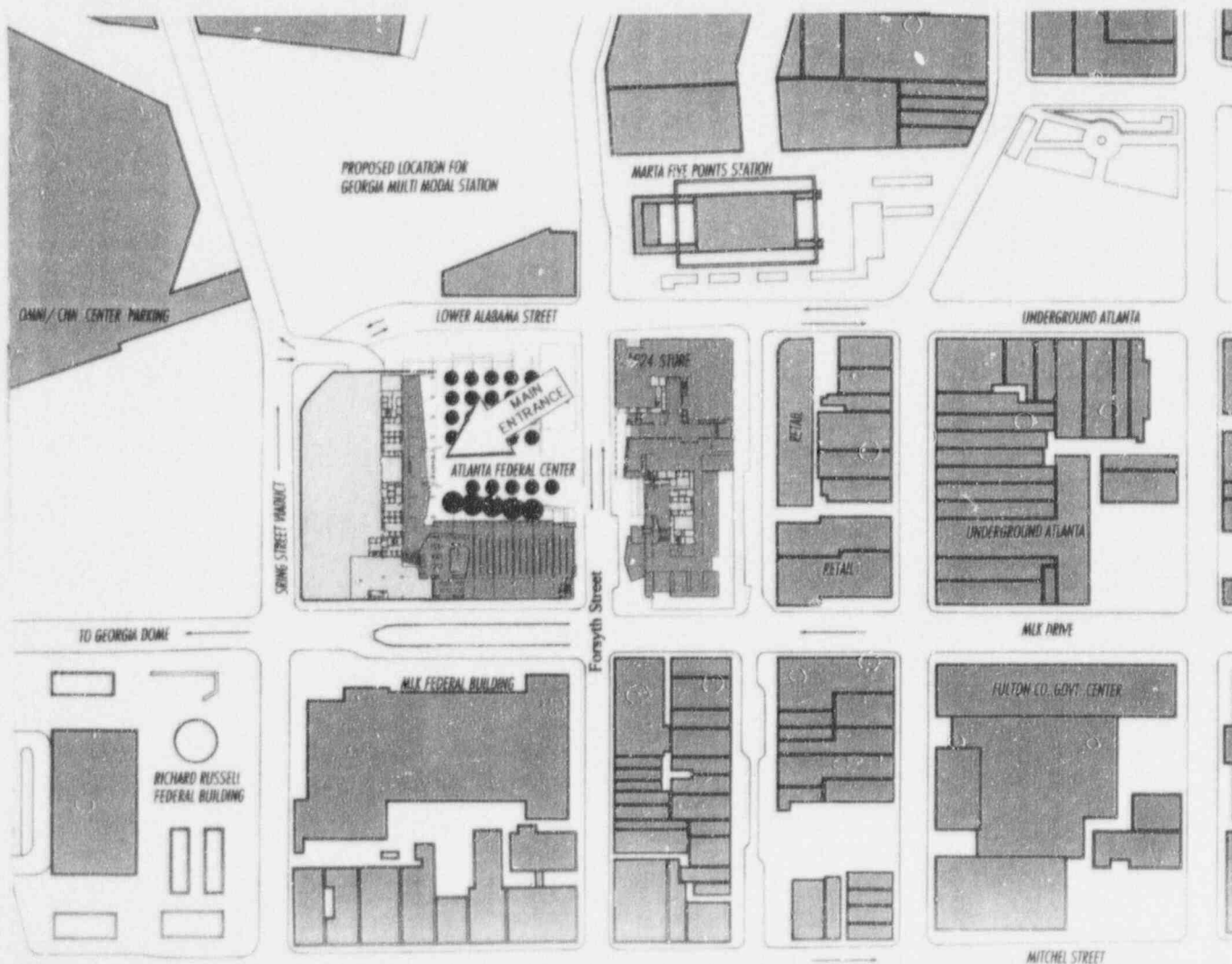
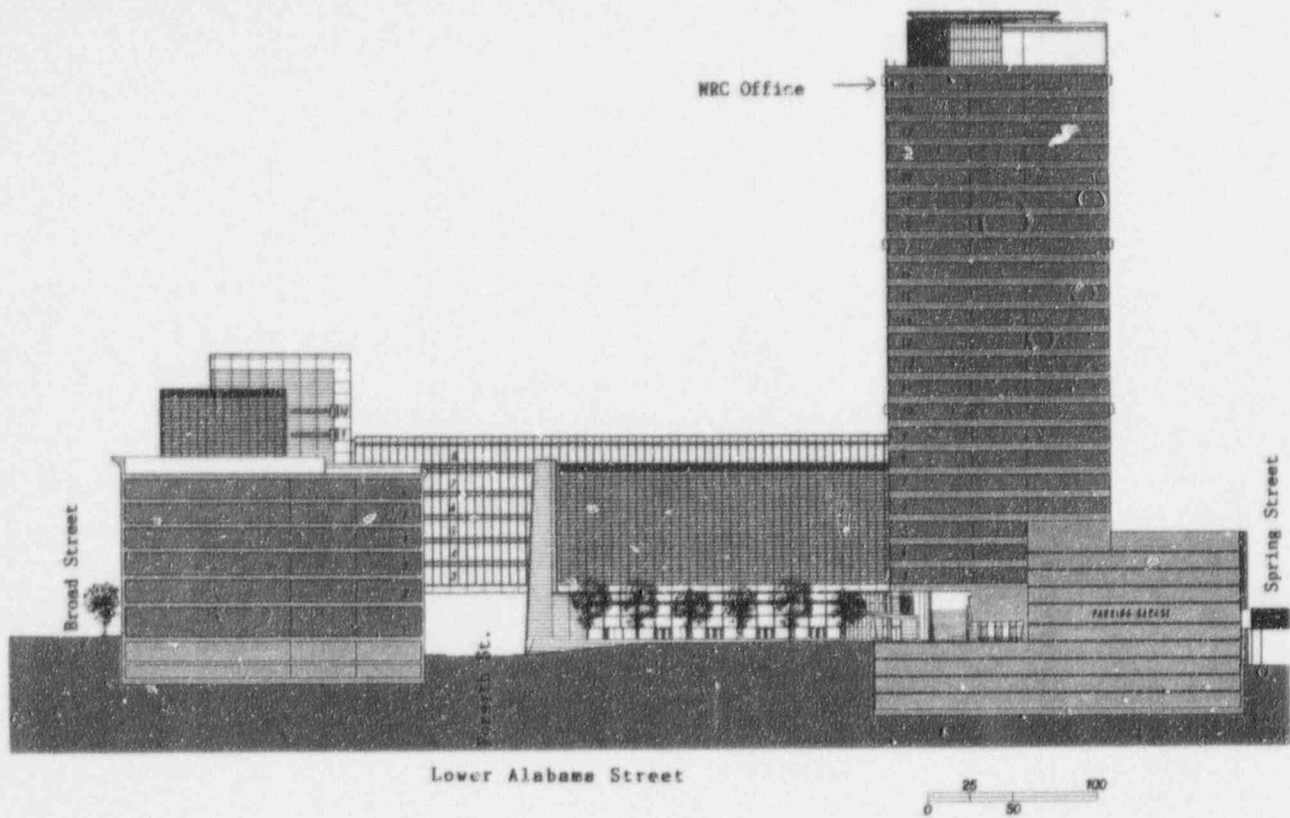
