This letter confirms the telephone conversation between CDR P. Blake of your staff and J. Ennis of this office on March 31, 1997, concerning a predecisional enforcement conference requested by the NRC which has been scheduled for May 1, 1997, at 10:30 a.m. The purpose of the conference is to discuss the apparent violations identified during a recent inspection. The results of this inspection were sent to you by letter dated April 4, 1997.

The purpose of the meeting, as previously described in our April 4 letter, is to obtain information from you prior to taking final enforcement action on the findings from our inspection. You should be prepared to discuss the root causes for the findings, significance of the issues and the corrective actions you have or will implement in response to the findings.

The location of the meeting will be at the NRC Region II Office, Atlanta Federal Center, 61 Forsyth Street SW, Suite 23T85, Atlanta, Georgia 30303. This meeting will be held in the 24th Floor Conference Room, Room 24T20. This meeting is an open meeting as discussed in "Staff Meetings Open to the Public; Final Policy Statement" (September 20, 1994; 59 FR 48350).




