As I recall the conference call with Judge Frye on December 4, the Staff agreed to forward to the parties copies of all documents in the NRC files regarding the proposed Agreement with the State of Illinois. I note that in your letter of December 6 you state only that you have forwarded "copies of correspondence between the State and the NRC." The correspondence does not illuminate the remarkable request by Mr. Cunningham that the State should assume responsibility for both the Kress Creek and license-amendment proceedings. We hope that any NRC documents, regardless whether embodied in correspondence, including Staff memoranda prepared before or after the meeting, notes taken at the meeting, or any other documents concerning the


