Dear Dr. Friedman,

This letter should serve as confirmation of our telephone conversation on January 30, 1985.

Firstly, I would like to apologize for failing to inform the Nuclear Regulatory Commission of a change in plans. However, as I mentioned, our operation never got off the ground and radioactive substances were not used or purchased. As that being the case, I thought that notification was unnecessary.

I will be moving the facility to another location, most probably on the New Jersey shore. While no definite address has been decided upon, one should be found within the next six months. Until that time, and after appropriate notification to you, please be advised that my mailing address should be used. The Philadelphia address, as noted on the letterhead of this correspondence, should serve for such a purpose. It is my medical office.

As per our discussion, I would like the current license to merely be amended to prohibit the use of controlled substances. Enclosed, please find a check payable to the United States Nuclear Regulatory for \$120.00 (One hundred and twenty dollars). This should cover the cost for amending the license in such a manner.

When my plans are better defined, I will be in touch with you regarding a subsequent amending.
