This is in reference to the Allied Corporation Pottsville Plant Byproduct Material License No. 37-16924-01, which we would like to amend as follows:

DELETE the 3M Model 3E40 sealed source loaded with 190 mCi of Krypton 85 gas. This source will be removed from the Index Control Systems Model 015030 source housing by the Index Co. representative and shipped to Index Co.

ADD to our license a 3M Model sealed source containing 500 mCi of Krypton gas, with a source No. 4089. This source will be housed in an Index Control Systems Model 015030 source housing and will be used to measure the thickness of plastic film and sheet.
