1. The Human teeth will be disposed after storage for about 6 months via dissolving in HCl and then by diluting in H₂O until the level of radiation confirms and below the safe limit given by HEC in regulation.
2. Calcium phosphate powders (radioisotope) mostly P₃₂ and Ca 45 active will be disposed as No. 1 above.
