ISSUANCE OF DIRECTOR'S DECISION UNDER 10 CFR §2.206

Notice is hereby given that the Director, Office of Nuclear Reactor Regulation, has issued a decision concerning a petition dated October 1, 1985 submitted by Robert L. Anthony. The petitioner requested that the Nuclear Regulatory Commission take certain actions with respect to applications filed by the Philadelphia Electric Company (PECo) with the Delaware River Basin Commission (DRBC) regarding water usage for the Limerick Nuclear Generating Station, Unit 1. Principally, the petition requested that the Nuclear Regulatory Commission stay DRBC consideration of the PECO applications and require withdrawal of these applications until PECO complies with certain environmental license conditions imposed by the NRC.

The Director, Office of Nuclear Reactor Regulation, has determined to deny the petition. The reasons for this decision are explained in the "Director's Decision Under 10 CFR 2.206", DD-85-18, which is available for public inspection in the Commission's Public Document Room, 1717 H Street, N.W., Washington, D.C., and at the Local Public Document Room at the Pottstown Public Library, 500 High Street, Pottstown, PA.
