SUBJECT: FEE FOR LICENSE 47-23070-01

License 47-23070-01 was issued April 5, 1985, in accordance with Putnam General Hospital's January 29, 1985 letter requesting an amendment to License 47-3012-01 to change the name from Kanawha Valley Radiologists to Putnam General Hospital. The Hospital stated that the change did not affect any aspect of the license except the licensee name. A \$120 fee was paid for the amendment.

Since Kanawha Valley Radiologists, Inc. will still exist as a legal entity in West Virginia, new License 47-23070-01 was issued on April 5, 1985 to Putnam General Hospital and License 47-23012-01 was terminated. This action was taken to maintain separate institution codes for each organization in the event Kanawha Valley Radiologists, Inc. applies for a license in the future. Since all conditions of the license, except the name of the licensee, remained the same, including the expiration date, and since an amendment-type review was performed (see Paul Guinn's 3/29/85 Conversation Record), the \$120 fee collected on February 25, 1985 is the correct fee for the issuance of License 47-23070-01.
