Good afternoon Mr Fuller,

I am reviewing the license amendment request for NRC License No. 11-27312-01, dated March 19, 2020, which requested that Mark Alan Crandall be added as an authorized user. Based on the information that you provided, it appears that his board certification was acquired in 2012. Please note that NRC Form 313A (AUD) (attached) states that "Training and Experience, including board

certification, must have been obtained within the 7 years preceding the date of application or the individual must have obtained related continuing education and experience since the required training and experience was completed. Provide dates, duration, and description of continuing education and experience related to the uses checked above."

Has Mr. Crandall been listed as an authorized user on any NRC or Agreement State licenses within the last 7 years? If so, please provide that information.

If the answer to the above question is 'no,' please provide information related to his continuing education and experience in Section 3 of NRC Form 313A (AUD).

You do not need to include a preceptor attestation, because he is Board Certified.
