This is in response to your letter dated March 18, 1985, in which you requested, pursuant to the Freedom of Information Act (FOIA) copies of draft and final letters from the NRC to Rep. Edward Markey concerning the Grand Gulf 1 nuclear power plant.

In a telephone conversation with Natalie Brown of my staff on March 26, 1985, you narrowed the scope of your request to include only those letters to Rep. Markey dated between January 1983 and March 18, 1985.
