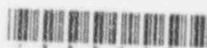

The purpose of this modification is to provide funding in the amount of \$42,000 which increases the obligated amount from \$683,400 to \$725,400. Accordingly, the contract is revised as follows:

1. Under Section B.4, "CONSIDERATION AND OBLIGATION--DELIVERY ORDERS. (JUNE 1988)," the first sentence of paragraph (e) is revised to read as follows:

(e) The amount presently obligated with respect to this contract is \$725,400.

All other terms and conditions of the contract remain unchanged.

Total FY95 obligation amount: \$265,200.00
