### *Re: Request Under The Freedom Of Information Act*

To Whom It May Concern:

On behalf of ENSR Corporation, pursuant to the Freedom of Information Act, 5 U.S.C. §552, I request the following:

A copy of all reports, documents, citations, communications, and the like issued by the Nuclear Regulatory Commission regarding the Brookhaven National Laboratory site and/or the administration of that site by Associated Universities, Inc.

For the above request, the following definitions apply:

"Communication" as used herein includes any written or graphic statement signed or otherwise adopted or approved by the person making it, including, without limitation, communications by e-mail, Internet, and facsimile, and any stenographic, electrical or other recording or transcription thereof which is a substantially verbatim recital of an oral statement by the person making it and contemporaneously recorded.

"Document" as use herein shall mean the original and each non-identical copy (whether different from the original because of marginal notes, or other material inserted therein, or attached thereto or otherwise) of any written, reported, recorded or graphic matter, however produced or reproduced, whether delivered, sent or received, including drafts and both sides thereof, and including, but not limited to, e-mail; Internet; facsimile; paper; books; letters; correspondence; telegrams; cables; telex messages; memoranda; checks; typed or handwritten notes, notations, work papers, transcripts, minutes, reports, recordings of telephone discussions, conversations, or other communications, or of interviews or of conferences or other meetings, envelopes, messages; bulletins; notices; instructions; bills; cash register receipts; order forms; invoices; purchase orders; maps; charts; plans; specifications; change orders; diagrams; surveys;



blueprints; floor plans; photographs; affidavits; statements; opinions; reports; studies; analyses; evaluations; contracts; agreements; leases; permits; instruments; ledgers; journals; financial statements; statistical records; desk calendars; appointment books; diaries; expense account records; lists; tabulations; summaries; sound recordings; computer printouts; data processing input; and output; microfilm; all other records kept by electronic, photographic, or mechanical means; and items similar to any of the foregoing.
